#### **Inaugural Speech of APQN seventh President**

Esteemed dignitaries, honored guests, distinguished members of the audience and dear ladies and gentlemen,

I bring to you my warm greetings from the Kingdom of Bhutan and thank you for the special joy of this evening.



It is with deep joy and humility that I acknowledge this privilege to make a few inaugural remarks on behalf of the seventh Board of Directors of the largest agency for quality assurance in higher education – the Asia Pacific Quality Network.

At the outset, I would like to offer my sincere gratitude to the sixth Board of Directors led by a highly distinguished and dedicated President, Prof. Jianxin Zhang, who successfully completed two terms as the head of the Asia Pacific Quality Network. The Secretariat to the APQN also deserves our heartfelt appreciation for taking care of the administrative tasks and the Independent Council for conducting the election of the seventh Board successfully.

I would also like to offer my heartiest congratulations to the seventh Board of Directors who were elected with overwhelming support from the members. We look forward to working together to ensure quality in higher education that is beneficial, relevant and current to the needs of changing times. We commit ourselves to fulfilling the mandate entrusted to us. We will work towards finding innovative, flexible and inclusive solutions to the challenges posed and opportunities provided by the prevailing circumstances. We shall work towards finding ever better ways to achieve the highest possible standards in relation to our work.

I am personally honored to take up the role of leading the Network to greater heights with the blessings and support of all of you involved in this critical task. This is an opportunity for a small country like Bhutan, where Gross National Happiness is the way of life, to serve beyond our borders in the field of quality higher education. I am inspired by the leadership in my own country where we emphasize quality and relevance besides access and equity.

His Majesty the King constantly reminds us that "in preparing our youth for the future, we must take advantage of available technologies, adapt global best practices, and engineer a teaching-learning environment suited to our needs. Technology is the argument of our time and a major indicator of social progress".

It is only appropriate to have this event here in Singapore as Singapore is considered an example in the provision of quality education particularly higher education. We thank EDUVALUE in Singapore for hosting and making all the arrangements for this event.

Talking about the Singaporean education system, we are aware of its achievements particularly in relation to the outstanding PISA test results scored by its youth. Even Bhutan, through the personal initiative of His Majesty the King, has adopted and adapted Singaporean education especially in the technological field. We deeply appreciate the achievement made by this beautiful country.

The seventh Board comes from different cultural backgrounds with varied experiences and motivation to work as a family to benefit the Network. We are privileged by the trust and confidence bestowed upon us. Taking over the baton from the largest country by one of the smallest is a heavy task. But I am personally committed to serve the family of this Network that stands to attain the goal of "Dissolving Boundaries for a Quality Region" and the mission of "enhancing the quality of higher education in Asia and the Pacific region through strengthening the work of quality assurance agencies and extending the cooperation between them".

Quality in higher education is a complex and somewhat elusive concept. Trying to ensure quality, therefore, is even more complex and must be handled using diverse approaches that befit different countries and regions of the world. At this juncture, we move from thinking about preparing work-ready graduates to future-ready graduates. Aspiring to provide quality higher education is the first step to providing relevant experiences in the classrooms – policies to translate into practical engagement of learners. We must look ahead and beyond 21st Century skills and adopt technology to skill, re-skill and up-skill through relevant curriculum options, experiential learning processes, authentic assessment practices to develop required competencies in the learners.

As I take on this big responsibility, I propose to move the Network further guided by the 3CS – Constitution, Collaboration, Continuity, and Sustainability.

For any action that we undertake, we will be guided by the Constitution of the Network. We would encourage participation and input from the members from the region and beyond for collaboration and cooperation to develop the strategies and implement the actions. We will adopt, adapt and adjust to the needs of the volatile, uncertain, complex and ambiguous (VUCA) world for continuity of the practices and change thereby making them current and relevant. We will not work as if we have inherited the Network from our past six Board of Directors but as if we have borrowed it from our future Boards to make it sustainable.

We would like to use the Strategic Plans 2019-2022 as the springboard for the next three years (2022-2025) or even beyond to meet the Sustainable Development Goals (SDG) or Agenda 2030 of ensuring 'inclusive and equitable quality education and lifelong learning opportunities for all' (SDG 4). This will guide effective

implementation of the activities of the three years. We will reflect on the documents already in place to continue improving with the guidance of the Board, particularly the outgoing President.

We have seen our Network grow from 222 member-agencies in March 2019 to 268 members as of today. We will work towards making our family even bigger.

More agencies are expected to get themselves assessed to join the Asia Pacific Quality Register (APQR). We will continue to facilitate the creation of an enabling environment for encouraging to join the Register through the guidance of the APQR Chairperson.

I have been greatly inspired by Simon Sinek who said, "The role of a leader is not to come up with all the great ideas. The role of a leader is to create an environment in which great ideas can happen." I see myself in this role to ensure the fruition of our collective vision.

I look forward to working closely with all of you and our member-agencies.

#### **President**



Mr. Nar Bahadur Raika is the seventh President (2022-2025) of the Asia Pacific Quality Network (APQN), the largest and most influential non-profit/non-government organization in quality assurance of higher education in the Asia-Pacific Region. He is the Specialist (Advisor) to the Quality Assurance and Accreditation Division, Department

of Adult and Higher Education, Ministry of Education, Bhutan. Prior to the present position he has worked as a teacher, lecturer and then chief program officer after joining civil service in 1988.

He earned his M.Ed. degree from the University of Newcastle, Australia; Advanced Diploma in Educational Studies from the University of Leeds, United Kingdom; and B.Ed. degree jointly from the National Institute of Education, Bhutan and Institute of Education, University of London, U.K.

During his 34+ years of service he has also served as a member Academic Board, Royal University of Bhutan (RUB), External Examiner, Examinations Secretary, Head of Math department, B.Ed. Programme Leader, Royal Civil Service Commission panelist, Higher Education Reform, to name a few.

He has facilitated many workshops on teaching mathematics, assessment techniques, mentoring trainee teachers, and quality assurance in tertiary education. He was one of the consultants on continuous assessment in Laos. He was the co-researcher with Prof. Maureen Bell, University of Wollongong, Australia on "Teaching and learning at the Royal University of Bhutan".

In addition to writing articles in relevant publications, Mr. Raika has made notable contributions to the development of several important publications like "Teaching Primary Mathematics Handbook", "NIE Examinations Handbook", "Teaching Practice Handbook", "B.Ed. Primary Handbook", "Continuous Formative Assessment Guidebook" and "Idea Folder in Teaching Mathematics". He worked in the task-force in developing Bhutan Qualifications Framework, Bhutan Qualifications Authority draft Bill, Bhutan Professional Standards for Teachers, and other documents related to quality higher education.

Currently, he is also a member of Academic Planning and Resource Committee (2<sup>nd</sup> term) for the RUB and active member of Evaluation Association of Bhutan and Bhutan Switzerland Society. He is a core trainer for the accreditation exercises of higher education programmes and institutions.

#### Vice President



Prof. Dr. Galina Motova is Vice President of APQN (2019 – 2022, 2022 – present). She is the Director of the National Centre for Public Accreditation (NCPA), Russia. She obtained her PhD and DSc degrees from Moscow State Pedagogical University.

She has more than 25 years of work experience in the field of quality assurance, including senior positions at the National Accreditation Agency (NAA) (1995  $^-$  2009) and the National

Centre for Public Accreditation (2009 - present).

Dr. Motova is a certified ENQA expert, who has taken part in ENQA reviews of QA agencies and HEIs.

She has organized international forums, assemblies, and conferences of quality assurance networks ENQA, CEENQA, and APQN (CEENQA General Assembly, St.

Petersburg 2006; ENQA Members Forum, St. Petersburg 2014, APQN Annual Academic Conference and General Meeting, Moscow 2017).

Galina Motova has been a participant in international projects Align (Tempus), SAGRIS (Erasmus+), and DEQAR Connect (Erasmus+). She was a member of ENQA's working groups on Excellence and Academic Integrity (2012-2014).

Galina Motova is rightly considered one of the founders of the system of quality assurance in the Russian Federation and a leading researcher in the field of quality assurance who has participated in the development and implementation of QA criteria and policies at the national level. She is among the authors of the Russian National Reports to the Bologna Process Conferences of Ministers responsible for Higher Education (2007, 2009 and 2015).

Dr. Motova, as Editor-in-Chief of the journal "Accreditation in Education" (established in 2005), has put a lot of effort into promoting quality assurance and the best national and international practices in Russia and abroad.

Dr. Motova has widely lectured on the current issues of education and quality assurance. She has provided specialized quality assurance training for more than 10,000 experts and HEI staff members during the last ten years. She has coordinated numerous accreditation procedures for higher educational institutions in Russia and abroad and participated as an expert and an observer in international quality assurance reviews of HEIs.

Galina Motova authored and co-authored more than 250 publications, including three monographs. She has also been awarded the titles of "Honorary Worker of Education of the Mari El Republic" (2004) and "Honorary Worker of Education of the Russian Federation" (1994).

#### Secretary /T reasurer



Ms. Pingping Liu, Associate Professor, is the Vice President of Shanghai Education Evaluation Institute (SEEI), China. She is mainly engaged in educational evaluation, research and management in higher education and Chinese-foreign cooperative education, and is responsible for the project department of evaluation in these fields. She has participated in editing books such as "Educational Evaluation Regulations" and published papers in educational

evaluation for core journals. She obtained her master's degree in English Language and Literature at the College of Foreign Languages, University of Shanghai for Science and Technology (USST) in April 2005. Prior to SEEI, she worked as teaching staff in higher education and elementary education for years.

#### **APQN Past President - Prof Dr. Jianxin Zhang**



Professor Dr. Jianxin Zhang is the fifth and sixth President (2016-2019; 2019-2022) of the Asia-Pacific Quality Network ("APQN", the largest and most influential non-profit and non-government organization in quality assurance of higher education in the Asia-Pacific Region). She is Co-chair of the Asia-Pacific Quality Register (APQR), Professor of Yunnan University, General Secretary of Yunnan Association of Higher

Education (YAHE) and Advisor of Council for CHEA/CIQG in USA (2012-2019; 2022-).

She obtained her PhD degree at Peking University in China, and obtained her Master degree at the Swiss Federal Institute of Technology (EPFL) in Switzerland. She was a visiting scholar in Asia-Pacific Program of Educational Innovation for Development (APEID) of UNESCO.

Her main focus now is the practices and researches of quality assurance. As the local host, she successfully organized the 2015 AAC in Kunming, China. She led over 30 on-site evaluations to various higher education institutions, designed the framework of program evaluation, and conducted over 30 workshops on QA in China, Pakistan, Sri Lanka and other countries or regions. As an APQR panelist, She evaluated the Fiji Higher Education Commission, the Russian Register and other QAAs in this region. She is one of the review panelists on the CHEA/CIQG Quality Platform Review on the Students Learning Outcomes (SLOs), and the site review leader of APQN Quality Label (APQL) on Accreditation of Internationalization to Symbiosis International (Deemed University) in India. She presented her research at the Asia-Pacific Sub-regional Preparatory Conference for World Conference on Higher Education, participated in International Forum for Education 2020 organized by East-West Center in USA and over 20 international conferences in USA, Russia, Switzerland, Sweden, Australia, Pakistan, India, China and other countries. She has visited over 60 countries /regions on various academic assignments and QA matters.

She has been teaching for over 40 years in comparative education, quality assurance, qualitative research methods and other 20 courses, supervised over 60 postgraduates in Yunnan University. She presided and engaged in over 60 research projects both domestically and abroad, e.g. "APQN Sustainable Development", "INQAHE-APQN Survey of Internal and External QA Landscape". She has published over 30 books (6 monographs, 4 translated books, 26 edited books) and over 250 papers. Among them, 10 received official governmental academic awards both domestically and abroad.

#### **APQN Board Director - Dr Jagannath Patil**



An internationally recognized quality assurance professional, Dr. Jagannath Patil is the former President of Asia Pacific Quality Network [APQN], the regional network of QA bodies from over 50 countries. Besides being the first Indian to head APQN, he was also an elected president of global quality network - INQAAHE in 2015-2016, being the first Asian expert to become INQAAHE President. He is also the founder Chairperson of Asia Pacific Quality Register [APQR]. He currently serves on APQN Board as Co-opted

Director as the Chairperson of APQR Council (2019-2022).

With experience of his long tenure as Adviser at National Assessment and Accreditation Council of India, JP was in Japan for an year on invitation by NIAD QE as a Specially Appointed Professor.

#### Initiation of APQN 2022 in mist of Covid-19 pandemic

EDUVALUE proposed holding APQN 2022 AAC and AGM Singapore to the AQPN Board of Directors a few months after holding APQN 2021 webinar on November 27, 2021, as the world and Singapore relaxed its travel restrictions in the wake of the Covid-19 pandemic.

After much deliberation, the APQN Board of Directors has settled on 2nd April 2022 as the launch date for APQN 2022. Six members of the EDUVALUE staff were assigned to oversee the conference's advertising, locations, tours, meals, lodging, transportation, and paper submissions. A timeline and associated tasks were drafted for APQN Board approval indicting 15 milestones to be achieved till the D-day of the APQN 2022. Due to Singapore relaxing its travel restrictions for Covid-19, many events were competing for venues during the same time period as APQN 2022. 

#### Launch of APQN 2022 and Digital LMS submission for paper


It was announced on April 2, 2022 (without a confirmed venue) that APQN 2022 would be held, and a call for papers was issued with a submission deadline of July 30, 2022.

# APQNews (Issue 26, 2022)



For the first time in APQN AAC's history, all registration of interest for paper submission and final paper submissions are handled digitally through the EDUVALUE LMS system, saving a great deal of time and effort in subsequent consolidations of papers and recording of author details and follow-ups.

A total of 79 papers was submitted, the APQN paper selection committee completed the paper grading and acceptance of papers was by August 6, 2022. All authors are informed of their paper selection outcomes by August 8, 2022.



#### **Delegates from 27 Countries came to APQN 2022 in Singapore**

Overall, 120 delegates signed up for the event, which is a smaller turnout compared to other regional APQN AAC and AGM gatherings due to the inconsistency of Covid-19 policies and the increased international travel costs of airfare and accommodations brought on by global inflation. Attendees and presenters represented 27 countries at the conference.

Although a few APQN Board members, speakers, and a few attendees were unable to attend due to unforeseen circumstances at the last minute, the event still saw about 113 delegates from educational QA accrediting organization, regulatory bodies, and universities from Australia, Bahrain, Bangladesh, Bhutan, China, Germany, China Hong Kong, India, Indonesia, Japan, Kazakhstan, Kyrgyzstan, Malaysia, Maldives, Mongolia, New Zealand, Pakistan, Philippines, Russia, Samoa, Sri Lanka, Thailand, Timor-Leste, Turkey, United Kingdom and Vietnam, and delegates from Singapore.

#### Day 1: 24 Nov 2022

The sixth and seventh APQN Board members and APQR Council representatives arrived at EDUVALUE's office by 4.30 pm. A Zoom link was set up for those who couldn't travel to Singapore.

Day 1 saw the conduct of three meetings: APQN Finance Committee Meeting that was chaired by APQN sixth and seventh Vice-President Prof. Galina Motova, the first Board Meeting was chaired by APQN sixth President: Prof. Dr. Jianxin Zhang and

APQR Council Meeting was chaired via zoom link by APQR Chairperson and APQN Board Dr. Jagannath Patil.

The APQN Secretariat office from Shanghai, represented by APQN Secretary/Treasurer Mrs. Pingping Liu and APQN Administrator Mr. Le Fang, joined in via zoom together with participants from India, Dr. Jagannath Patil and APQN Board Director, Prof. Dr. S. #### Release of the book entitled "APQN Research on the COVID Impact"

At the open ceremony of 2022 APQN Academic Conference at Life-long Learning Institute in Singapore, APQN book entitled "APQN Research on the COVID Impact on the Quality of Higher Education" has been released to the public.

Jianxin Zhang(APQN President), Galina Motavo(Vice President), Mr. Jun Barry Aw Yong (Local host), together with Dr Wang Libing (Chief, Section for Educational Innovation and Skills Development, UNESCO Asia and Pacific Regional Bureau for Education) released this book.



In the past 2-and-half years, APQN carried on many actions during the COVID pandemic, including 4 surveys, 7 interviews, 1 online forum,3 international online conferences, 1 online-teaching standard and other researches. The current book is the result of most of APQN researches and projects COVID-19.

The book consists of 10 chapters including 4 parts: Part I is the research of chapters 1-3, which describes the impacts of COVID outbreak, such as "Survey of the COVID Impact on the HEIS", "Survey of the COVID Impact on QAAs" and "Survey on the Effectiveness of Online Teaching in the HEIS". Part II is the research of chapters 4-7 which narrates the uncertainty and challenges during the of COVID-19, such as "Review of APQN 2020 Online Forum", "APQN Board Interviews on HE Quality in COVID Crisis", "Qualitative Research on Effectiveness of Online Course during COVID-19" and "Academic Review of the 12th Higher Education International Conference". Part III is the research of chapters 8-10 which shows the results, such as "Meta-Review to APQR", "APQN Standard for Online-Teaching QA" and "COVID Response Mechanism".Part IV is annex 1-6 which provides more details to the researches carried on during the pandemic, such as 4 surveys, 7 interviews, and "APQN Standard for Online-Teaching Quality Assurance" issued globally on May 30, 2021.

#### **APQN Annual General Meeting**

The APQN Annual General Meeting took place in Singapore on November 26,

2022. It was chaired by Prof. Galina Motova, APQN Vice-President, Deputy-director of National Centre for Public Accreditation (NCPA), Russia

The meeting began with the report of the APQN Secretariat made by Liu Pingpin, Xu Yingjie, Fang Le, and Fan Cunyao. The Secretariat is currently administered by the Shanghai Education Evaluation Institute (China). The report specifically emphasized an increase in the number of Network



members from 222 in March 2019 to 268 as of today. Nowadays, the 268 APQN members come from 47 countries. There are 51 full members, 20 intermediate members, 17 associate members (agencies outside the Asia-Pacific), 14 observers, and 165 institutional members. There is also one individual member. The Secretariat stressed that accreditation agencies in the region and around the world are highly interested in the APQN membership.

The fifth and sixth APQN President, Professor Dr. Jianxin Zhang, reported on two terms of chairing the APQN Board. During the past six years, particularly as a result of the vigorous efforts and initiatives of Dr. Jianxin Zhang and the dedicated work of the Board, APQN has achieved strong financial stability and attracted the attention of numerous stakeholders, including quality assurance agencies, HEIs, and partner organizations. Every year, the Network gains more members and expands the scope of its political influence in the area. Many events have been held during this period, including Annual Academic Conferences, General Meetings, Summits, and International Forums. Even during the COVID-19 pandemic, when the borders were closed and communication was limited, APQN continued its activity and held conferences in an online format. The research into the influence of COVID on teaching and learning and the effectiveness of quality assurance agencies was carried out. The following papers were published: Anthology 2019, Anthology 2021, and "APQN Research on the COVID Impact on the Quality of Higher Education." APQR and APQL projects aimed at the external review of agencies and HEIs are being implemented. The electronic edition of APQNews is published twice a year, and the Annual Report is published every year.

Professor Dr. Jianxin Zhang commended the Board for their productive collaboration and wished the newly elected Board success in their efforts to promote the Network's sustainability.

The sixth Board members were awarded certificates. The election results of the new seventh Board were declared and finalized during the General Meeting. The new Board includes the following members: President: Nar Bahadur Raika from Bhutan,

Vice President: Galina Motova from Russia, Secretary/Treasurer: Liu Pingping from China and Board Directors: (1)Ex-Officio as Immediate Past President, Jianxin Zhang from China; (2) Ex-officio as APQR Chair, Jagannath Patil from India; (3) Elected Jun Barry Aw Yong from Singapore; (4) Elected Srinivasa Chandramouliswar Sharma from India; (5) Elected Umankulova Onolkan from Kyrgyzstan; and (6) Elected Timur Kanapyanov from Kazakhstan.



Dr. Tariq Al-Sindi, the Chief Executive of the Education and Training Quality Authority of Bahrain, the Secretary General of the Arab Network for Quality Assurance in Higher Education (ANQAHE) and an Executive Board member at the International Network for Quality Assurance Agencies in Higher Education (INQAAHE) awarded certificates to the new Board members.

The key highlight of the General Meeting was the inauguration address made by the seventh President, Mr. Nar Bahadur Raika. In his speech, he expressed gratitude to the sixth Board, emphasized the achievements accomplished, highlighted the effective work of the conference organizer, EDUVALUE (Singapore), and thanked the members of the Network for the great honour of electing him as the President of one of the most reputable and influential quality assurance networks in the region.

Assuming full responsibility for APQN further progress, he stated the following: "As I take on this large responsibility, I propose to move the Network further guided by the 3 Cs — Constitution, Collaboration, Continuity, and Sustainability." Mr. Raika also noted how much the world has changed recently and that the Network needs to adapt to these changes. "We will adopt, adapt, and adjust to the needs of the volatile, uncertain, complex, and ambiguous world for continuity of the practices and change, thereby making them current and relevant. Meanwhile, we will look ahead to the future, take into account development trends, and support new ideas and innovations in quality assurance. We will not work as if we have inherited the Network from the sixth Board of Directors but as if we have borrowed it from our future Boards to make it sustainable."

## PRESIDENT REPORT

#### **Prologue**

Dear Boar directors, dear members in APQN big family, a very good afternoon!

Welcome you to AGM!

On behalf of APQN Board Directors, Jianxin Zhang, Galina Motova, Pingping Liu, Jagannath Patil, Deepthi Bandara, Farida Nurmanbetova and Barry Aw Yong, Here I present "APQN President Report" for you to approval.

6 years ago (2016), in Fiji known as the "heaven on earth", I was elected APQN fifth President, taking over the baton of "APQN Long March" from 4<sup>th</sup> president, Dr. Jagannath Patil. Since then, I have shouldered APQN responsibility as the parent of this international family.



In 2019, I was once again honored to be elected as the sixth president. Together with all the Board directors and members, we spent the difficult time under the great challenge of the COVID-19 pandemic. Today, we are happy to welcome APQN seventh Board. On behalf of the fifth and sixth Board, let's warmly welcome and congratulate the new Board directors!

In my inaugural speech 6 years ago, I said: "I will faithfully perform the duties of APQN President". I also raised a question: "Everyone in APQN, especially myself, should not ask what APQN can do for us, but what I can do for APQN?" Today is the time to answer that question and to check whether the Board has fulfilled the promise and implemented the tasks or not.

Based on "APQN Constitution" "APQN Procedure Manual", 2 APQN Strategic Plans (2016-2019; 2019-2022), 13 Issues of APQNews (Issue 14-26), 5 APQN Annual Reports (2016-2021), on behalf of APQN fifth and sixth Board, here President Report will presented in 10 aspects: (1) APQN organization construction; (2) Human resource development; (3) Regulation and system construction; (4) Academic development; (5) COVID Pandemic response mechanism; (6) Construction of external QA mechanism; (7) Construction of internal QA mechanism; (8) Publications; (9) Financial status; (10) Spirit legacy.

## I. APQN Organization Construction: Mission and Framework

#### 1.APQN Governing body

APQN governing bodies and authorities are the General Council and the Board. The General Council is comprised of Full Members, Intermediate Members, Associate Members, Institutional Members and Individual Members.

APQN Board consists of the President, Vice-President, Secretary/Treasurer(ex-officio), immediate Past President(ex-officio), and four other elected directors, and other directors whom the Board may decide to co-opt, to a maximum of four co-opted directors on the Board.




Fig. 1 APQN Administration framework

APQN Board may establish committees, such as the Executive Committee, Membership Committee, the Finance Committee, the Office Bearers, etc. According to APQN projects and tasks, the Board can appoint Project Group Leaders who, if not already directors of the Board, may be co-opted as directors of the Board to a maximum of two co-opted Project Group Leaders as outlined.

#### 2.APQN mission, value, vision, principle and ultimate goal

APQN mission is to enhance the quality of higher education in the Asia-Pacific Region through strengthening internal and external quality assurance in all kinds of organizations and extending the cooperation among them.

APQN value is to be committed to the quality of higher education, and supportive of both internal and external quality assurance in the Asia-Pacific Region.

APQN vision is to promote quality culture; to be a self-sustaining non-government and non-profit organization; and to be the first point of reference, efficient in its operations and sharing information among members.

APQN principles are: (1) procedure-based; (2) capacity building; (3) self-reliance and information-sharing; and (4) sustainable development for final goal.

APQN ultimate goal is "Dissolving Boundaries for a Quality Region".

#### **3.APQN History Development**

On a sunny day 19 years ago (January,2003) in Hong Kong, China, a small core group of QA persons (Peter Cheung of HKCAA, David Woodhouse of AUQA, and VS Prasad of NAAC) with a common wish for excellence in quality of higher education in the Asia-Pacific Region had a meeting... and here APQN came into being!

Time flies! 19 years had passed by before we realized it. After the 19-year development, APQN has become the largest and the most influential international, non-governmental, non-profit organization in the Asia-Pacific Region with 268 members from 47 countries/territories.

In the past 19 years, APQN has gong through 4 development stages: (1)Before 2003, it is initiative development stage focusing on APQN goal, mission, vision, etc. (2) from 2005-2012, it is basic-construction development stage, focusing on website, constitution, etc.; (3) from 2012-2016, it is self-sustainable development stage, focusing on APQN survival because of the cease of grand-support; (4) from 2016 to 2022, it is self-sustainable development stage, focusing on third generation of quality assurance. From 2022, APQN will enter new development stage, focusing on fourth generation of quality assurance.




Fig. 2: APQN history development stage

Founded in 2003, APQN has been focusing on higher education QA, insisting the mission of "To enhance the quality of higher education in Asia and the Pacific region through strengthening the work of quality assurance agencies and extending the cooperation between them" (APQN Mission Statement, 2015) to carry out international cooperation within the Asia-Pacific Region.

## II. Human resource development

In the filed of human resource, APQN has been continuously working hard on three aspects: Board Directors, APQN members and 3.Consultant Database.

#### 1.APQN Board Directors

In the past 6 years, APQN has two terms of Board: the fifth and sixth Board.

At the fifth Board, there are 9 Board Directors in total: Jianxin Zhang (President), Angela Hou Yung-chi (Vice President), Li Yaogang and Pingping Liu (Secretary/Treasurer), and Directors: Jagannath Patil (Ex-Officio as Immediate Past President), Manuel Corpus, Zita Mohd Fahmi (dropped out), Galina Motova, Malini Nair-Prasad and Deepthi C. Bandara(2018-2019).






Fig. 6: Category percentage of APQN members




Fig. 7: The composition of APQN consultant database

## III.Regulation and system construction

In the filed of regulation and system construction, APQN has covered 5 important aspects: (1) completing "APQN Procedure Manual"; (2) amendments of "APQN Constitution"; (3) making 2 "Strategic Plans" (2016-2019; 2019-2022); (4) establishing "9-Ones system"; (5) holding 5 AGMs.

#### 1. Completing "APQN Procedure Manual"

Since its inception in 2003, APQN has released 2 versions of the Manual: (1) Version 1 with 8 chapters was released in 2007; (2) Version 2 with only 1 chapter on Finance was released in 2011, supplementary to Version 1.

In the past decade, APQN got financial support from World Bank and UNESCO, but since 2012, the found was ceased, and APQN stepped into a self-sustaining era. Naturally many procedures are of no use.

In 2016, at the first Board meeting of the fifth Board in Fiji, the Board considered that it's high time for APQN to revise the Manual. The Board approved that Prof. Dr. Jianxin Zhang as the group leader to revise APQN Procedure Manual with the financial support of "the Self-fundraising Project: APQN Sustainable Development" donated by Mr. Zhang Jianping, CEO of Wuxi Shenzheng International Logistics Co. Ltd., China.

Based on APQN Procedures Manual (version 1) in 2007 and Finance Manual (Version 2) in 2011, referencing INQAAHE General Procedures Manual (version 17) in 2013, "APQN Procedure Manual (Version 3)" with 12 chapters has been revised and updated by Prof. Dr. Jianxin Zhang with the help of Ms. Xinna Zhang, Angela Hou Yung-chi. The Manual was endorsed by APQN Board in September, 2017. In October 31, 2017, APQN released "APQN Procedure Manual (version 3)" to the public in the website (http://www.apqn.org/about-apqn/apqn-brochures). At the open ceremony of 2018 APQN Academic Conference held in Nagpur, India, APQN Board Directors together with distinguished guests, keynote speakers officially released the Manual.

As we all know, the Manual acts as guidance for APQN, lays guidelines for its functioning, gives astonishingly positive results in its functioning in the area it

belongs to. The implementation of the Manual has made APQN working smooth, question free and transparent which is the need of the sustainable development of APQN.

#### 2. Amendments of "APQN Constitution"

According to the decisions of the first Board meeting of the sixth Board geld on March 30, 2019, it's high time for APQN to amend APQN Constitution (v. 9.0), which was amended five years ago.

Approved by the sixth Board, 1 9-step procedure was made as the schedule of the Amendments of APQN Constitution. In September, the amendment has been completed, including the 5 aspects: (1) Adding the member category of "Individual Member"; (2) adding APQN mission, value, vision and goal which APQN has implemented for more than a decade; (3) adding the benefits of APQN members according to "APQN Procedure Manual" released in 2018; (4) some expressions that might cause confusion; and (5)a few more changes have been made to fine tune Constitution.

APQN Constitution is of great significance to APQN: it is not only the foundation of APQN, but also the soul of APQN. By the end of 2019, APQN had amended it (9 version), such as adding individual membership category.




Fig. 9: 2.Amendments of "APQN Constitution" in 2019

## 3. Making 2 "APQN Strategic Plans" (2016-2019;2019-2022)

APQN Strategic Plan is as the guidance for the new general council in the next three years. In order to realize the final goal of "Dissolving Boundaries for a Quality Region", the fifth and sixth Board of APQN made the APQN Strategic Plan (2016-2019; 2019-2022).

The Board took on the persistent mission with new attitude and new perspectives. The five principles of the Strategic Plan are: (1) target-orientated principle; (2) project-orientated principle; (3) SMART Project principle (specific, meaningful, agreed-upon, results-oriented and tractable); (4) Win-Win Principle; and 5) principle of sustainable development. The five key words are "procedure-base, capacity-building, self-reliance, information-sharing and sustainable development".

2 APQN Strategic Plans (2019-2022) focus on completing 7 goals and actions

along with 9 targets in the next three years.

### 4. Establishing "9-ones system"

Based on "APQN Procedure Manual", we made APQN annual routine work as "9-One system" in order to systematically and continuously promote the development of higher education QA:

- 2) Once a year, holding an AGM (annual general meeting) of the General Council (5 times)
  - 3) Once a year, holding a quality award ceremony (5 sessions)
  - 4) Once a year, holding the "Global Summit" to QA experts (3 sessions)
- 5) Once a year, MPI-APQN holding international conference on "teaching QA" in Macao (6 sessions)
  - 6) Once a year, publishing an APQN Annual Report (6 issues)
- 7) Once a year, publishing an academic anthology of selected papers (5 volumes)
  - 8) Once a year, publishing APQNews twice a year(12 issues)
  - 9) Twice a year, holding QA online forum (2 sessions)

It is based on the "9- One system", we made APQN calendar at the beginning of each year, while at the end of each month we made monthly calendar to inform all APQN Board Directors to keep in mind what APQN has done last month and what APQN will do next month. By this way, APQN can systematically function very well without delaying or missing the tasks should be done.

#### **5. Holding 5 Annual General Meetings**

The Annual General Meeting (AGM) is the important annual meeting of the General Council (GC). The governing bodies and authorities of APQN are the General Council and the Board. The GC is composed of Full Members, Intermediate Members, Associate Members and Institutional Members.

According to "APQN Constitution", APQN must hold Annual General Meeting(AGM) once a year. Since 2017, APQN held 6 AGMs (table 2). In the year of 2020, there was no AGM because of the COVID-19 pandemic, all the conferences, meetings and activities stopped in the whole globe .

## 2. APQN Research on the COVID Impact on the HE Quality

Based on the actions taken above, APQN published one book entitled "APQN Research on the COVID Impact on the HE Quality in the Asia-Pacific Region", which includes most of APQN actions under COVID-19. The book consists of 10 chapters in 4 parts:

Part I is the researches of chapter 1-3, which describes the impacts at COVID-19 outbreak, such as "Survey of the COVID-19 Impact on the HEIs", "Survey of the COVID-19 Impact on QAAs" and "Survey on the Effectiveness of Online Teaching in the HEIs".

Part II is the researches of chapter 4-7 which narrates the uncertainty and challenges during the of COVID-19, such as "Review of APQN 2020 Online Forum", "APQN Board Interviews on HE Quality in COVID-19 Crisis", "Qualitative Research on

Effectiveness of Online Course during COVID-19" and "Academic Review of the 12th Higher Education International Conference".

Part III is the researches of chapter 8-10 which shows the results, such as "Meta-Review to APQR", "APQN Standard for Online-Teaching QA" and "COVID-19 Response Mechanism".

Part IV is annex 1-6 which provides more information in detail during COVID-19, such as 4 surveys, 7 interviews, and "APQN Standard for Online-Teaching Quality Assurance" issued globally on May 30, 2021.




Fig. 17: Three books published during the COVID pandemic

#### 3. APQN Standard for Online-Teaching Quality Assurance

Since campus lockdown restrictions as a result of the COVID-19 pandemic, online teaching has emerged onto the global higher education stage as a leading means of "adjusting to new environments". The results of "APQN survey on COVID-19 impact" conducted in 2020, showed that 68% of the respondents are "not satisfied" with online teaching.

At APQN 8<sup>th</sup> forum entitled "Influence of COVID-19 on Higher Education Quality Assurance" held on July 28, 2020, an urgent demand made APQN decide to develop APQN Standard for Online-Teaching Quality Assurance.

Based on the survey and the key elements of standard for online-teaching quality assurance were developed by Delphi Method, "APQN Standard for Online-Teaching Quality Assurance" was released in June, 2021.

APQN standard consist of 5 criteria, 14 indicators and 46 observation points. The 5 criteria are (1) Online teaching environment; (2)Teachers' online teaching; (3) Learners' online learning; (4) Presentation of online teaching outcomes; and (5) Online- teaching quality assurance. ## VI.Construction of external quality assurance: APQR

Asia-Pacific Quality Register(APQR) is a Register of external quality assurance agencies (EQAAs) that demonstrated certain thresholds of maturity.

After the "quantity era", today HE has entered into the "quality era" and as "the gate keepers of quality", EQAAs are playing more and more important roles, the social status and responsibility become more and more prominent. How to guarantee the quality of the QAAs?

Since 2015, APQR began its official journey to review Fiji Higher Education Commission (FHEC). Since 2017, 9 QAAs have been accepted onto APQR.

## VII.Construction of internal quality assurance: APQL

Asia-Pacific Quality Label (APQL) as regional/international accreditation was

launched in January, 2014. The overall objective is to support, develop, improve and enhance excellent internationalization or student learning outcomes (SLOs) in higher education institutions (HEIs) and programs in the Asia-Pacific region.

In April, 2019, the expert APQL review panel visited Symbiosis International (Deemed University), (SIU), India. This is the first review of the internationalization processes.

SIU is one of the few exceptional universities that has embarked on this international journey for the heartfelt cause of enabling and empowering international students in India. SIU is the first university in India to be conferred this prestigious label and this is fitting as they are the pioneers in the field of internationalization for higher education.

#### VIII. Publications

As for publications, APQN has published 5 Academic Anthologies, 12 Issues of APQNews and 5 APQN Annual Reports.

#### 1. 4 Academic Anthologies

















## 3. 5 APQN Annual Reports


Fig.22: 6 APQN Annual Report (2016-2021)

#### **QA ACTIVITIES**

#### MPU-APQN jointly organized the 14th HE International Conference

The Macao Polytechnic University (MPU) and the Asia Pacific Quality Network (APQN) jointly organized "The 14<sup>th</sup> Higher Education International Conference on Online Teaching and Sustainable Quality Assurance: Challenges and Perspectives", held online from 29th to 30th November 2022. Over 20 experts from the UK, Belgium, Russia, Philippines, Pakistan, Sri Lanka, Mongolia, Chinese Mainland, Hong Kong and Macao presented their papers.





The online conference attracted 200 experts and Ph.D. candidates from all over the world to participate. They actively engaged in exchanging views and interacting freely during the conference.

Professor Im Sio Kei, Rector of MPU, delivered the opening speech, remarking how online teaching has rapidly developed into a mainstream teaching method around the world, and that standards and requirements for quality assurance in higher education have changed accordingly. MPU and APQN continued taking on the role of building a platform and cooperating for the eighth time in hosting the higher education international conference. This year, the conference focused on the themes of "digitalization", "cross-border", "AI application", "information technology innovations in accreditation", "online teaching and assessment", coping with changes for cross-border cooperation, and different methods of assessments and standards in the post-pandemic era. The conference aimed to provide exchange opportunities and share teaching research experiences and practices for participants around the world.

Mr. Nar Bahadur Raika, newly appointed President of APQN, delivered the welcome speech, exclaiming that the conference was held at just the right time. The pandemic has brought us many lessons in adapting online and blended learning, and adapting to the use of technological gadgets, so relearning, reskilling, and upskilling are the hot topics in higher education. Higher education institutions have to work toward facilitating the transnational mobility of graduates competent enough to learn while they continue to learn. Therefore, it is time to move away from teaching knowledge and skills to helping them to maneuver through the challenges of unlearning. He looked forward to seeing all the experts sharing practical ways of enhancing teaching quality, and remarked that APQN is committed to the continued

collaboration with agencies working for the enhancement of quality higher education.

This conference invited famous experts and scholars of higher education quality assurance to deliver keynote sessions. Mr. Douglas Blackstock, President of the European Association for Quality Assurance in Higher Education (ENQA) presented on "Quality Assurance in the Changing World of Higher Education – A Perspective from Europe". He said that quality is best advanced when institutions, students, and stakeholders collaborate in developing expectations and sharing effective practices. Driven by the pandemic, the greater integration of digital education into traditional approaches has changed the needs and expectations of students and staff. Trends in future European quality assurance frameworks are also beginning to move towards evidence-based, critical reflection and stakeholder consultation.

Mr. Albert Chow, Executive Director of Hong Kong Council for Accreditation of Academic and Vocational Qualifications (HKCAAVQ) presented a "Pilot Project on the Development of Applied Degree Programmes". He explained that the HKCAAVQ conducted research and consultancy on the development of applied degrees in Hong Kong. This project is going to complete with a view of making recommendations on the policy support, incentives, and implementation details for further avocation and support of vocational and professional education and training development in Hong Kong in the years to come.

Ms. Maureen McLaughlin, Academic Registrar and Director of Student, Library and Academic Services of Northumbria University, UK, spoke about "What have we learned from learning online?". She pointed out that the pandemic drove the higher education community more rapidly to adapt approaches to teaching and learning. The negative perceptions of online experience were explored, as were the established and evolving benefits, the challenges being addressed, and those that remain. A wider view of the total student experience should help us address the challenges and build on the positives highlighted by this monumental shift in learning delivery so that we can offer more transformational, sustainable, and carefully constructed learning opportunities for our students.

Prof. Galina Motova, Vice-President of APQN presented on "Aggregated ranking as a tool for evaluation of the quality and positioning of Asia-Pacific universities at the global level". She pointed out that various rankings and accreditation in the world are developing rapidly in the higher education system, but the overarching objective is the same: to enhance the quality of higher education. Through research, all data can be combined into a single aggregated ranking that ultimately serves as a tool for evaluating the quality of education. A new method is also provided for determining the top institutions, namely the league analysis method, which is used to create the global aggregated university ranking. This approach may also be viewed by the general public as a thorough and unbiased assessment tool.

In this two-day conference, more than 20 scholars presented papers in five parallel sessions. Various experts and scholars discussed the current situation and the future of quality assurance in higher education, innovation and influence in education evaluation, the mechanism and effectiveness of online teaching in various disciplines, digitalization of quality assurance, and more. The participants declared that they benefited from the exchanges at this conference.

## APQN Attending the "QAA at 25th Anniversary" Online Symposium

To mark QAA's 25<sup>th</sup> anniversary in 2022, QAA invited an expert panel to a conversation about what is quality. The "QAA at 25<sup>th</sup> Anniversary" Online Symposium took place on 27 September 2022. In this live online debate, an expert panel of speakers representing networks of quality


agencies based around the world unpacked what quality means from the perspective of global higher education communities.

The round-table discussion was chaired by QAA Chief Executive, Vicki Stott, and attended by Professor Jianxin Zhang, President of the Asia Pacific Quality Network (APQN), Professor Nadia Badrawi, President of the Arab Network for Quality Assurance in Higher Education (ANQAHE), Cynthia Jackson-Hammond, President of the Council for Higher Education Accreditation (CHEA), Douglas Blackstock, President of the European Association for Quality Assurance in Higher Education (ENQA), Anna

Prades, Treasurer and Executive Committee Member of the International Network of Quality Assurance Network of Institutions for Quality Assurance in Higher Education (INQAAHE).

Five speakers presented their ideas, including APQN multiple-quality idea based on a 360-degree quality cycle, INQAAHE quality internationally, CHEA academic quality, and ENQA holistic quality.

On behalf of APQN, Professor Jianxin Zhang gave a speech entitled "What is Quality -- Perspectives from the Asia-Pacific Quality Network(APQN)". She firstly introduced APQN, the largest and most influential international non-profit NGO in the Asia-Pacific region and then she put out a series of questions: (1) What is quality?; (2)what



is APQN multi-quality concept of higher education; (3)what is quality assurance; and (4) what is APQN quality model in higher education? By this way, she answered the questions accordingly, which contributed a lot of insights based on the Asia-Pacific perspective to this conference.





When it comes to what is "quality", President Zhang described "Quality is like love. When there is love, we feel it, talk about it, recognize it and know what we are talking about. But when we try to define love, we are left standing empty-handed." She pointed out, different stakeholders have different understandings of quality. In a word, "Quality is doing the right things in the right way with the right persons in the right places." In addition, President Zhang shared the multiple quality concept of APQN, showed the influence of the change process of APQN member types on its multiple quality concept, built an APQN model of higher education, and gave the example of the Asia-Pacific Quality Label (APQL) for internationalization to demonstrate the concept of quality assurance in higher education. In the end, President Zhang emphasized that APQN regards quality as a continuous development concept. The implementation of the specific connotation of quality needs to go through an improvement "PIRI" cycle: (plan, implementation, reflection, and improvement).

Higher education is a global concept with international partnership and collaboration proving central to the success of UK and international higher education institutions. This live round-table discussion covers different ideas from APQN in the Asia-Pacific region, ANQAHE in Arab, CHEA in the U.S., ENQA in Europe, INQAAHE in the globe, and QAA in the UK. It is truly a diversified international debate on "Quality".

#### **NIAD-QE held University Quality Assurance Forum 2022**

The NIAD-QE University Quality Assurance Forum 2022 entitled "Connecting inside and outside of university: Toward further integration of learning styles" was held virtually on September 28, 2022, with nearly 400 participants from across Japan and beyond.

FUKUDA Hideki. Ph.D., President of NIAD-QE addressed the opening and an acknowledgement to the supporting organizations and thanked distinguished speakers and all the participants for being present.

The four distinguish speakers, Ms. Terry Neal, Chief Advisor Policy of New Zealand Qualifications Authority (NZQA), Dr. Injong Park, Adjunct Professor at Graduate School of Education, Korea University and Head of the ON Institute of Lifelong Education, Dr. Mohamad Afzhan Khan, Assistant Vice President (Open Learning), University of Cyberjaya and Former Director of accreditation of Prior Experiential Learning (APEL) Centre, Open University Malaysia (OUM), and Prof. IWANAGA Masaya, Ph.D., President of the Open University of Japan (OUJ) then gave their presentations sharing their expertise and experiences.

Ms. Neal delivered a speech on a subject of flexible learning and micro-credentials in New Zealand to kick-off the forum. She introduced NZQA and NZQCF, New Zealand Qualification and Credential Framework, then the theory of micro-credential use in New Zealand, from how it had been formally introduced into the framework and quality assurance system to decrease the skills mismatch between industries and workers and enable people to learn throughout their lifetime, and to how it has been implemented at many workplaces. Ms. Neal highlighted the importance of being responsive to the needs of industries and learners, along with changing society, for scaling up the use of micro-credentials in New Zealand.

Dr. Park introduced National Institute for Lifelong Education (NILE), Korea, and its two major scheme, Academic Credit Bank System (ACBS) and Bachelor's Degree Examination for Self-Education System (BDES) as Dr. Park himself was one of the founding members of the institute and Ex-director of the ACBS. ACBS recognizes individual learning experiences as credits that can be accumulated towards university equivalent degree. BDES enables people to earn an academic degree through a course-by-course examination with their own study resources. Dr. Park shared the long-term progress of the two systems and their quality control, and emphasized the necessity of promoting such systems that recognize diverse lifelong learning and an appropriate quality control in order for credentials to be acknowledged positively in the society.

Dr. Afzhan introduced the APEL system which grants qualifications to learners with cumulative learning and experiences through a course of assessments, and how

micro-credential is used in Malaysia to help people up-skill which also leads to enhance country's human resource development capacity. He then pointed out from the university perspective existing and possible challenges on recognizing different styles of learning. Dr. Afzhan stressed the importance of democratization of education and providing equal accessibility to learners with different barriers to learning by not only providing flexible learning but also advancing APEL system where informal and non-formal learning are officially recognized.

Prof. Iwanaga presented the overview of OUJ, introducing its education system and how it had changed the major class format over the course of the pandemic, along with the recent implementation of Internet Based Test (IBT). In the light of increasing demand for recurrent education, OUJ is also considering a use of micro-credentials to further foster lifelong learning. While OUJ has challenges to address such as equivalency to other universities' degrees and qualifications, and to continue facilitating recurrent education, Prof. Iwanaga underscored the importance of such educational reforms to timely respond to a social demand in education and human resource.

Following the four experts' presentations, moderated by Prof. NODA Ayaka, Associate Professor, Research Department of NIAD-QE, the panel discussion was centered on the topics of social perception of degrees and qualifications earned by flexible and non-traditional learning outside the universities, how we evaluate those learning and define the equivalency to conventional academic degrees, and the possible challenges for its process. Questions from the audience were also shared at the discussion, and the speakers exchanged their perspectives sharing more of the educational systems and approaches from each of their countries.



#### **APQN Attending the Stavanger-Lingnan Research Symposium 2022**

From October 30<sup>th</sup> to November 1<sup>st</sup>, 2022 the Stavanger-Lingnan Research Symposium 2022 was held in Zoom. It was co-organized by the University of Stavanger in Norway and Lingnan University in Hong Kong. With the topic: "International mobility, University Governance, and Labor Market Relevance: The Nordic and East Asian Perspectives", there were more than 50 participants from 8



countries and regions around the world. 25 speakers presented their researches in 6 panels, including International Higher Education and Student Mobility, Education Policy and Quality Assurance, Emerging Issues in Higher Education, Student Mobility Across China's Greater Bay Area, Graduate Employment and Entrepreneurship and Innovation.

APQN President Zhang, together with Shirun Wang and Wenjing He (Graduates of Research Institute of Higher Education at Yunnan University) attended the symposium at 20: 45 Beijing time. Their topic is "New Normal" for Panel 2 Quality Assurance of Higher Education: Overview of Academic Conference on COVID-19 Response Mechanism and Impact on Quality Assurance for Higher Education in the Asia-Pacific Region.

The presentation includes 5 aspects: (1)Introduction of APQN and AAC on COVID Impact; (2)Double Dilemma: Difficulties in the Asia-Pacific region; (3)Dual Measurements: Responses in the Asia-Pacific region; (4)Hand in hand: Progress in the Asia-Pacific region; (5)Conclusion.

First of all, it is the introduce APQN and AAC on COVID Impact. 2021 AAC received 36 papers from 15 countries and regions, such as China, Pakistan, Russia and other countries. Dr. Peter J. Wells, chief of higher education from UNESCO, gave a keynote speech entitled "Reinventing the Role and Place of Higher Education for a Sustainable Future". 9 authors from 8 countries and regions reported the research results at AAC online.

Dr. Zhang introduced 11 APQN QA activities during COVID, such as "APQN Survey of the COVID impact on HEIs", 5 changes brought by COVID and 3 trends of quality assurance for HE in post-epidemic era. Facing difficulties such as "poor qualities for online teaching" and others, APQN has contributed some researches, including 3 cases of internal experience and 2 cases of external standers. Finally, Dr. Zhang made a conclusion: "Facing the COVID Pandemic, we have a long way to go before we realize the ideal scenario of good quality assurance for HE in the Asia-Pacific Region. We are looking forward to meeting you at 2022 APQN Academic Conference in Singapore on November 25-27, 2022."

#### **ULAB Receives APQN Best internal QA Award for 2022**

#### Awardee's Words from University of Liberal Arts Bangladesh

It is an honour to receive the APQN Best Internal Quality Assurance Award for 2022. We acknowledge the significance of this recognition given to organizations with extraordinary quality assurance contributions and good practices that have potential of replications in the Asia-Pacific region. ULAB will continue to strengthen it quality assurance endeavors as it expresses it deepest gratitude to APQN for its continuous support and encouragement.



The University of Liberal Arts Bangladesh (ULAB) is a private liberal arts-based university in Dhaka, Bangladesh. Founded in February 2002, permission to open was received from the University Grants Commission (UGC) of Bangladesh in November 2003, pursuant to the Private University Act 1992. ULAB was formally launched at a ceremony on October 1, 2004. ULAB's vision is to become the best university in Bangladesh and a leader in South Asia. Just four years after its inception, ULAB has initiated steps towards quality assurance. The university is among the founding members of the Education Quality Assurance Foundation (EQAF) where its Vice President Kazi Anis Ahmed was appointed as Joint Secretary. In 2010, the university's application for institutional membership at the Asia Pacific Quality Network (APQN) was approved. The following year, the university underwent the Singapore-based Shujog Impact Assessment to find out the effect of the university's work on its community. ULAB started on building its own quality assurance unit in 2015 with the appointment of Professor Jude William Genilo as Director of its Institutional Quality Assurance Cell (IQAC).

ULAB's IQAC manages and oversees policies and procedures to assure the standards of its awards and the quality of learning opportunities and to support the

enhancement of learning and teaching. It manages key quality assurance processes, including curriculum design and approval; programme self-assessment reports and improvement plans; student and stakeholder feedback systems; and periodic internal and external reviews and audits.

In January 2016, ULAB entered into an MOU with the University Grants Commission (UGC) for the three-year HEQEP project: "Establishment of IQAC at ULAB". By June 2016, ULAB's IQAC was equipped with its own office, facilities and staff. By the project's end in 2019, it has conducted 47 training workshops with 1,701 participants from both academic and non-academic staff. Three manuals have been written (approved by the University Syndicate/BOT) – University Governance Manual, Course Teaching Manual and Curriculum Design Manual. Two surveys have been initiated – Organizational Needs Survey and Institutional Quality Assurance Survey. Several committees have been established – Self-Assessment Committee, Quality Assurance Committee, Curriculum Development Committee, Governance Manual Working Committee, Procurement Evaluation Committee and Assessment of Learning Manual Working Committee.

The university's five program offering entities have completed a Self-Assessment Report, External Peer Review Report, Improvement Plan, Outcome-based Education Curriculum and Strategic Plan. The accomplishments during the UGC HEQEP Project enabled two program offering entities to gain program accreditation. The Computer Science and Engineering (CSE) Department received IEB (Institute of Engineers Bangladesh) in October 2017. The Media Studies and Journalism (MSJ) Department obtained accreditation from the Swiss-based Global Alliance for Communication Management and Public Relations in June 2021.



ULAB's quality assurance activities are not limited to the UGC HEQEP Project. In September 2019, it has obtained International Organization for Standardization (ISO) 9001:2015 Quality Management System Certification. The university has completed three year of certification and is onto its next cycle in September 2022. Under this certification, ULAB's IQAC has formulated it Quality Manual, Quality System and Procedure Manual and Assessment of Learning Manual. It has likewise established its Quality Management Committee and trained 15 internal auditors. In November 2022, it received the APQN Best Model Internal Quality Assurance Award as a testament to its achievements.

Therefore, since its inception in 1994, AIUB has been working to promote Internal Quality Assurance within different academic and administrative activities. AIUB has been the first university in Bangladesh to introduce Quality Assurance Center (QAC) in 2008 and approached to Philippine Accrediting Association of Schools, Colleges and Universities (PAASCU) for international accreditation for different programs of AIUB.
