ACHIEVEMENTS OF THE EDUCATIONAL PROGRAMMES

The quality of educational programs implementation

Quality management system (QMS) was developed in MPSU in accordance with MS ISO 9001-2008. There is a certificate of QMS compliance in the sphere of planning, development and realization of educational activity in the sphere of higher professional education.

In 2010 MPSU was awarded with gold medal and laureate diploma "100 best organizations of the Russian Federation. Science. Innovations. Research and Development" in nomination "100 best organizations in Russia in the sphere of science and education".

Educational programmes under accreditation are winners of "The best educational programmes of innovative Russia" award in 2012, 2013.

Providing of the actual education content

Educational programmes are edited in accordance with the changing legal system of the Russian Federation, labor market needs and modern trends in the development of science.

Staff (faculty's competence)

Teaching and learning activities are performed by 38 people, 31 of them are on the full-time basis (81%). The number of teachers with academic degrees and titles is 33 people (86%), 12 of them are Doctors of Sciences, professors.

Demand of graduates

Postgraduate students succeed in work in the sphere of law enforcement activities and human rights activities, government and municipal authorities.

Educational resources

Educational programmes are provided with corresponding auditory classes, laboratories and equipment. There are also multimedia classes with internet access where tasks for students are placed for optimization of educational process.

The university library possesses scientific and educational materials as well as electronic manuals and schoolbooks.

Scientific activity

During the period under review teachers took part in 15 conferences, seminars and academic conferences of different level where they delivered reports, participated in discussions and acted as organizers. For 2011-2013 there were published 10 monographs, over 90 research articles, 33 schoolbooks, and comment to law system (4 of them have designation of Educational Methodological Association on Education). Teachers and postgraduate students carry out research studies. Results of these studies are discussed at training and scientific conferences of different level, seminars, roundtable discussions, and are published in

the collections of scientific papers, national scientific reviews including peer-reviewed and recommended by Higher Attestation Commission.

International projects and academic mobility of students

Students and postgraduates students of the cluster of these educational programmes are on probation at universities of China.

In the frameworks of international cooperation the department works together with Harbin Pedagogical University (Nanjing), Beijing Pedagogical University (Beijing), Xuzhou Pedagogical University (Xuzhou), Hebei Pedagogical University (Shi Jiazhuang).

COMPLIANCE OF THE EXTERNAL REVIEW OUTCOMES WITH THE NCPA'S STANDARDS

STANDARD 1. Policy (mission, vision) and procedures for quality assurance of educational programme

Compliance with the standard: **substantial compliance**

Good practice

Development of educational programmes fully complies with the mission and strategy of the university.

The mission is aimed at creating educational, research and innovational environment, which allows training specialists oriented towards professional growth, civil values and social responsibility.

The University's and the Faculty's management set up goals and objectives for the Faculty and the study programmes.

The University developed and uses the quality management system (QMS).

- It is necessary to identify more precise objectives and tasks of educational programmes taking into account their specifics and to attract all interested parties to this process: students, employers, professional community.
- Well-defined strategies of development of educational programmes for the right positioning on the market of educational services should be developed based on the mission and objectives.
- The majority of internal stakeholders are not familiar with goals, strategic objectives and mission. The panel members had the impression that the level of corporative culture is not high enough.
- It is necessary to prepare and confirm an intermediate-range programme of development of the juridical education for three years.
- The quality management system (QMS) should be transparent and functional. With this aim the quality assurance policy should be discussed with the management at all levels involving all stakeholders.

STANDARD 2. Approval, monitoring and periodic review of study programmes and qualifications

Compliance with the standard: **partial compliance**

Good practice

The panel indicates that the review of syllabi and curricula is held annually according to the goals and outcomes of the educational programmes: the contents of the academic courses and methodological materials are updated with the account of the latest developments in science and technology, informational technologies, economy, culture and social policy.

Revision process of curricula and syllabi of academic courses is made due to approved procedure by the university.

The close contacts of the programme's management with employers were noted by the Panel as an example of good practice.

- It is necessary to involve students and student self-governing bodies in curriculum and syllabus design.
- There is need in opinion exchange between the programme's management, students and employers when introducing changes and amendments to the programme.
- It is necessary to make an effective QMS of education with participation of all parties of educational process, drawing special attention to notes, recommendations and proposals of employers; to get reviews from employers on the Bachelor's, Master's and Postgraduate's programmes.

STANDARD 3. Assessment of student learning outcomes / competencies

Compliance with the standard: **partial compliance**

Good practice

The procedure for formative and summative assessment of student learning outcomes/competencies is regulated by the documents approved by the appropriate structural units.

The monitoring of students' performance is conducted on a regular basis and includes the following forms of assessment: testing, individual assignments, presentations, selective electronic testing, examinations, and final state attestation.

The assessment of student learning outcomes is carried out by the teaching staff, which has a sufficient level of professional qualification on the basis of a rating system.

Te conclusions about the quality of education are made according to the results of scientific and academic activity of students.

One of the strengths of the programme is high employability of graduates.

- Well-defined criteria of assessment of students' achievements and their results of education are not available.
- Low involvement of students into the research activity, writing and publication of scientific articles co-authored by employers.
- There is no penalty system for plagiarism.
- The number of classroom hours for foreign language learning should be increased.
- It is necessary to sign some contracts with foreign HEI-partners on cooperation, so that students can undertake language internships abroad.
- It is necessary to create scientific groups and organize ongoing seminars at the department.
- Graduate employment centre should be created.

STANDARD 4. Quality assurance and competencies of teaching staff

Compliance with the standard: **substantial compliance**

Good practice

The evidence obtained through the interviews suggests that the teaching staff of the programme has sufficient qualification in their areas of expertise.

The panel indicates that there is close connection between the educational process and research.

The results of the teachers' research are regularly published in impact factor journals. The teaching staff actively participates in various international, Russian and university conferences, seminars and exhibitions.

- One of the indicators of an intermediate-range programme of development should be indicator "The number of foreign professors, invited for giving lectures".
- To promote scientific work publication with high impact-factor, there is need in administration support to the extent concerning highly qualified translation of these publications to English.
- It is necessary to create a system for stimulating the teachers to participate in human resource development programmes including exchange visits abroad.
- It is necessary to introduce a position of Deputy Director for international activities.
- It is necessary to develop Master's programme in English.

STANDARD 5. Learning resources and student support

Compliance with the standard: **partial compliance**

Good practice

The educational programmes are provided with the adequate number of classrooms, laboratories and equipment. Multimedia classrooms and internet resources are actively used for the academic process optimization.

The provision with textbooks is in compliance with the requirements of the Federal educational standards. Electronic textbooks and methodological materials are readily available to the students of the programme.

The majority of study courses are provided with the necessary electronic resources placed on the University's server.

The classroom computer time is allocated for students' independent work, research work and writing course and graduation papers.

- It is necessary to equip a criminalistic training area, a forensic laboratory and a court room.
- E-library of the university is not popular among students. Many students prefer to find information themselves in the Internet or to use library card-catalogue.
- It is necessary to introduce the system of distance learning with the use of ITK for ill health students and to create special conditions for them in classrooms.
- There should be access to WiFi in all buildings including hostel of undergraduates.
- It is necessary to work out a feedback system, for example to conduct anonymous student surveys on the assessment of the conditions of the educational process at the programme at least once a term.

STANDARD 6. Information system providing effective implementation of the study programme

Compliance with the standard: **substantial compliance**

Good practice

MPSU's management collects information from the departments on students' and teachers' participation in conferences, competitions and olympiads. Information system is formed long ago but it needs further development.

The majority of study courses are provided with electronic learning and teaching materials: working programmes, textbooks, testing materials and practical assignments.

- The system of collecting, analyzing and informing the public about the educational programme should be improved.
- The number of electronic educational resources on the programme should be increased.
- It is necessary to set up a system for monitoring, collecting and analysis of the information on educational programmes.
- A system for analysis of counterpart programmes should be formed.
- It is necessary to make the study materials more accessible to students.
- It is recommended to create a local social university network for interrelationships student/student, student/professor to provide social and academic-oriented style of communication.

STANDARD 7. Public information

Compliance with the standard: **substantial compliance**

Good practice

Public information is carried out via university's website, mass media and reference book for applicants.

Student recruitment work at the Departments and the Faculty follows the annual action plan.

The public is informed at the Faculty "Open Doors" Days.

Monitoring research about graduates' employment and occupations-ondemand on labor market are held. The results of the analysis of graduates' employment are discussed at the meetings of the university administration.

- The Panel indicates that at the moment of the site visit the official website didn't comply with the Rules of publishing and updating information about an educational institution (approved by the RF Government Regulation No 582 of 10 July 2013)
- It is necessary to conduct "Vacancies Fairs" inviting representatives of companies and institutions both from Moscow and other regions of the RF.
- Long-term strategy for the improvement of connections with employers should be developed.
- It is necessary to set up, organize and formalize a system of interaction between the HEI/Faculty and graduates.
- It is necessary to open a section on the website under the heading "The Programmes' Graduates and their achievements".

CONCLUSION OF THE EXTERNAL REVIEW PANEL

Based on the analysis of presented documents and data the External Review Panel came to the conclusion that cluster of educational programme "Jurisprudence" (030900.62); "Criminal code" (12.00.09); "Judicial practice; Public prosecutor's practice; Remedial and Lawenforcement Practices" (12.00.11); "Criminalistics; Legal-expert's practice; Investigation" (12.00.12.) complies to a considerable degree standards and criteria of public accreditation, elaborated by The National Centre for Public Accreditation. However there are spheres that are need to be improved.

In this case the Panel recommends the National Accreditation Board to accredit the educational programmes "Jurisprudence" (030900.62); "Criminal code" (12.00.09); "Judicial practice; Public prosecutor's practice; Remedial and Law-enforcement Practices" (12.00.11); "Criminalistics; Legal-expert's practice; Investigation" (12.00.12.) for the period of 4 years.
