Preliminary results of the Federal Internet-Exam for Bachelor Students held on April 20-30, 2015 in Russian HEIs

DECIDED:

- 1) To recognize that one of the mechanisms for direct and independent assessment of the quality assurance of education is created and approved.
- 2) To continue approbation of the Federal Internet-Exam for Bachelor Students in 2016.
- To engage associations of educational institutions, employers and Educational and Methodological Associations in the definition of the minimum of knowledge, which a graduate in each area of training should possess, for use while developing exam tasks in 2016.
- 4) To take into account the results of the Federal Internet-Exam for Bachelor Students, the direct and independent assessment of education quality, while conducting public accreditation and making accreditation decisions.
- 5) To place the presentation "Preliminary results of the Federal Internet-Exam for Bachelor Students held on April 20-30, 2015 in Russian HEIs" at the website of the National Centre for Public Accreditation.

2. G. Motova

The results of the Bologna Process Ministerial Conference in Yerevan (May 14-15, 2015): the new edition of the Standards and guidelines for quality assurance in the European Higher Education Area ESG-ENQA and European approach to quality assurance of joint programmes

DECIDED:

- 2) To accredit the educational programmes "Economics" (38.03.01, 38.04.01, 38.06.01), "Management" (38.03.02, 38.04.02) for the period of 6 years.

Consideration of the results of international external review of the two clusters of the educational programmes of Northern (Arctic) Federal University

DECIDED:

- 1) To accredit the educational programmes "Pedagogical Education" (44.03.01 (050100.62)), "Pedagogical Education" (44.03.05 (050100.62)), "Pedagogical Education" (44.04.01 (050100.68)) for the period of 4 years, after which NArFU has the right to submit to NCPA a Report on the Results of Corrective Actions in compliance with the recommendations of the external review panel. Based on this Report, at the next meeting the National Accreditation Board may decide to prolong the accreditation period to the full accreditation period.
- 2) To accredit the educational programmes "Physics" (03.03.02), "Physics" (03.04.02 (011200.68)), "Physics and Astronomy (Theoretical Physics, Physical Electronics, Physics of Condensed Matter)" (03.06.01 (01.04.02, 01.04.04, 01.04.07)) for the period of 6 years.
