

#### **ACHIEVEMENTS OF THE EDUCATIONAL PROGRAMMES**

#### The quality of educational programs' implementation

The evaluation of the graduates' learning outcomes is done on the basis of the analysis and assessment of entrance examinations, formative and summative control in all study courses, and the final attestation of graduates.

#### Providing up-to-date contents of education

Providing up-to-date contents of education takes place in accordance with the Federal State Educational Standards and the requirements of stakeholders.

The University regularly conducts surveys and interviews of employers, students, their parents, and school leavers. The findings are used for enhancing the quality of the academic process.

The teachers periodically update the contents of fundamental and applied courses in order to be current with the latest achievements in the sphere of psychology and social work. They have developed a number of courses and are using them in their work.

In order to improve the methodological provision of the programme's disciplines learning and teaching materials and guidelines are accessible in the electronic format.

#### Competency of the teaching staff

Highly qualified teachers, research and academic degree holders, participate in the delivery of the programmes. The teaching staff of the Institute of Education and Social Studies is comprised of 266 members including 43 Doctors of Sciences (6,2%), 179 Candidates of Sciences (67,3%) and 44 lecturers (16,5%) without academic titles.

### Employability of graduates

The University has established the "Association of the alumni and friends of the North Caucasus Federal University" whose activities are aimed at the organization of effective cooperation between graduates and employers, and successful socialization of graduates.

#### Material and technical resources

The material and technical resources are up-to-date and sufficient for an effective implementation of the educational process.

#### Research

Two research areas have been established at the Department of Social Technologies: «Technologies of social work with families and children», under the supervision of Dr. Of Education, professor Zritneva Elena Igorevna; «Psycho-Pedagogical technologies of personality development in education" under the supervision of Dr. Of Education, professor Klushina Nadezhda Pavlovna. Within the framework of these areas the

staff of the Department have been carrying out fundamental and applied research.

Every year students participate in different level conferences doing presentations and publishing articles. Since 2012 Bachelor and Master students have taken part in over 50 conferences of different levels. Master students participated in the collective monograph «Theoretical and methodological principles of innovative technologies in social work and education». Every year Master and Bachelor students under the guidance of research supervisors take part in the competition of graduation qualification papers.

### Academic mobility of students

The University is maintaining international cooperation with over 40 universities (Munich Technological University (Germany), the Prague Institute of Chemical Technology (Chez Republic), Baltic Higher School of Humanities in Koszalin (Poland), the Technical University of Chemnitz (Germany), Azerbaijan State Technoical University, Azerbaijan State Oil Academy, MEGA (Chez Republic), Slovak University of (Slovak Republic) and others. There is a bilingual Master Degree programme in Social Work and academic mobility programmes.

#### International projects.

The Institute of Education and Social Studies is conducting active international activity aimed at the development of research cooperation within the academic mobility and research programmes with the following international education and research centres:: the University of Rome «LaSapienza» (Italy); the University of Heidelberg (Germany); University of Manitoba (Canada); Oxford University (Great Britain); the Association MitOst (Germany); Canadian Centre on Disability Studies; Robert Bosh's Foundation (Germany); BMW Foundation (Germany); the University of Oregon (USA); University of Silesia (Poland).

# COMPLIANCE OF THE EXTERNAL REVIEW OUTCOMES WITH THE NCPA'S STANDARDS

# STANDARD 1. Policy (mission, vision) and procedures for quality assurance

# Compliance with the standard: **substantial compliance**Good practice

All those present at the interviews and meetings were familiar with the mission, goals, objectives and strategies which are formulated in the documents submitted to the review panel.

The policy and procedures of quality assurance of the study programmes have been developed on the basis of international standards of quality, the legal and normative basis of the RF and local legal acts.

The effectiveness of the achieving the goals of the study programmes is ensured by the effective system of quality assessment with the involvement of all stakeholders of the study process – teachers, employers and students.

The quality of the study programmes is supported by regular commissions from municipal and regional state business structures.

- The long term prospects of study programme development, strategic vision of goals and objectives should be reviewed. It is recommended to identify promising directions of programme development from the position of social business and social management.
- It is necessary to facilitate the integration of study programme into the learning environment of the University.
- The management of the study programmes should be formalized (e.g., to establish a Programme Committee, to clearly define the functions of manager and research supervisor of the programme).
- It is recommended to systematize and increase methods and ways of participation of teachers, students, graduates and employers in developing strategies of study programmes and quality assurance procedures.

# STANDARD 2. Approval, monitoring and periodic review of educational programmes

### Compliance with the standard: substantial compliance

#### Good practice

All the participants of the educational process: teachers, employers, students, representatives of professional community have an opportunity to voice their opinion on the contents and structure of educational programmes.

Students have a chance to enter a further education programme free of charge while studying on the main programme.

There is an annual monitoring of the effectiveness of the departments' performance and regular reviews of study programmes.

- The procedures of surveying students, employers and graduates on the issues of curriculum and syllabus design should be made more systematic and anonymous.
- It is important to develop the principles of providing students with real opportunities of choosing study disciplines and individual learning paths.
- It is necessary to expand and systematize ways and methods of interaction with graduates.
- It is recommended to develop criteria and introduce a ranking system of NCFU's study programmes; and to demonstrate the dynamics of ranking results.

# STANDARD 3. Assessment of student learning outcomes / competencies

Compliance with the standard: substantial compliance

#### Good practice

Educational programme «Social Work» (39.03.02) underwent a successful independent evaluation within the project «Federal internet examination in the sphere of professional education» (Certificate of Quality  $N^{\circ}$  2015/2/107 or 13.11.2015).



The high level of students' and graduates' competency is confirmed by the opinions of employers. The ranking system of knowledge assessment is effective. Students' and teachers' personal electronic accounts are actively used for interaction in the study process.

Regularly, two times a year there is independent assessment of student learning outcomes in the format of the Federal Internet Exam in higher professional education (FEPE).

Student surveys are held regularly in order to get feedback on issues of the organization of the study process and improving the objectiveness of assessment criteria.

The students are systematically involved in research projects. The results are presented as research publications, defense of research projects and participation in research conferences.

In order to facilitate the graduates' employability there is an annual vacancies' fair, which involves major employers from the city and the region. A career guidance service is in place. A high level of employability at the labour market is confirmed by documents, and opinions of representatives of the professional community and the alumni.

- It is necessary to increase the amount of time for learning foreign languages (by way of optional courses and further education parogrammes), thus creating favorable conditions for international mobility and bilingual education.
- It is recommended to increase the number of contact hours in the programme «Juridical Psychologist" and enhance the practice component in the training of students.
- International partnership should be expanded by way of implementing joint programmes, joint conferences, etc. It is necessary to develop student exchange programmes paying a special attention to the geographical proximity: Armenia, Azerbaijan, Georgia.
- A pool of certified funds of assessment tools should be developed.
- It is recommended to ramp up the activity of the Alumni Association Graduates should be more actively involved in the implementation and development of study programmes.

# STANDARD 4. Quality assurance and competency of teaching staff

### Compliance with the standard: **substantial compliance**

#### Good practice

The high level of the staff qualification and competence is confirmed by the number of degree and title holders, awards and certificates, published text books and manuals, grants, involvement in research work commissioned by municipal, regional administrative bodies and business structures.

A considerable number of teachers of the major departments (20%) have a high level of the English language proficiency and give lectures in the English in the programmes of bilingual education.

All teachers go through professional advancement programmes every 5 years.

- Teachers from other HEIs of the region and foreign teachers should be more actively involved in the education process, including those who work on part time and full time basis.
- It is recommended to develop and implement an incentive system for the teaching staff, taking into account the results of teaching, methodological, research, educational, administrative and other types of activity.
- It is necessary to promote the participation of teachers in international projects, exchange visits; to increase the number of publications including co-authored with foreign partners.
- $-\,\mathrm{It}$  is important to involve teachers in designing curricula, developing strategies and tactics of their implementation.

#### STANDARD 5. Learning resources and student support

### Compliance with the standard: substantial compliance

### Good practice

The material, technical and information resources meet the requirements of the Federal State Educational Standards and provide for the successful implementation of the programmes.

There is free unlimited WI-FI on the territory of the University and the student dormitories.

The library is stocked with all the necessary printed and electronic educational resources. The students have a free access to all library resources. The electronic resources include major national and foreign bases of text documents.

A well developed social infrastructure is in place. 100% of students are provided with accommodation in student dormitories.

NCFU has good sports and recreation facilities (a swimming pool is being built). All students have free access to all resources, which meets their cultural, sports and health needs.

- Students should be encouraged to use electronic and library resources, including those in foreign languages.
- It is recommended to make use of modern technical resources of employers in the study process on the basis of partnership agreements.
- It is important to provide students not only with study facilities but also with relaxation facilities in the study buildings for their recreation, meetings and communication.
- $-\operatorname{It}$  is necessary to enhance the activity on introducing inclusive education.
- Further education and LLL courses for different categories of learners (women, multi-childe families, retirees, migrants, and others) should be developed and introduced into the practice of educational process.
- It is important to monitor the students' opinion on the issues of resource provision of the learning process.

# STANDARD 6. Information system providing effective implementation of the study programme

Compliance with the standard: full compliance

### Good practice

The HEI has in place an electronic information system. The information on students' progress and achievements is published on the web site..

A ranking system of the performance of the HEI's structural subdivisions has been developed and implemented. Students and teachers are active users of their personal electronic accounts.

- It is necessary to make systematic and use information on student satisfaction with the programme in the management of the study programme.
- The development of electronic educational resources (electronic text books, electronic lectures, guide books).
- It is recommended to publish video lectures on the web site.
- It is recommended that the structural subdivisions responsible for implementing programmes enhance the mechanisms of strategic decision making, implement innovations in the process of long-term planning of study programmes development.

#### STANDARD 7. Public information

### Compliance with the standard: substantial compliance

### Good practice


Current, full and objective information about the study programmes is published on the NCFU's site.

The data on the contents, learning outcomes, the level of teaching, forms and methods of instruction and assessment, qualification of graduates are made known to employers in the sphere of social service of the city and the region.

Students, teachers and graduates are of high opinion of the programme. The programme enjoys high reputation and prestige among members of the public.

- It is recommended to put more emphasis on the information about the study programmes but not on the structural subdivisions implementing the programmes.
- It is important to develop different forms of informing the public about graduates and study programmes.
- It is recommended to create a positive image of the programmes' cluster from the position of social management, social entrepreneurship and social project management in the context of social economy and social business.

#### **CONCLUSION OF THE EXTERNAL REVIEW PANEL**

Based on the self-evaluation report analysis, documents and data submitted the External Review Panel has come to the conclusion that the cluster of study programmes «Social Work » (39.03.02, 39.04.02), «Management in Work with Youth» (39.04.03), and Further education programme «Juridical Psychologist" delivered by the Federal State Autonomous Educational Institution of Higher Professional Education "North-Caucasian Federal University" substantially comply with the standards and criteria of public accreditation of the National Centre for Public Accreditation.

The Panel recommends that the National Accreditation Board accredit the study programmes «Social Work » (39.03.02, 39.04.02), «Management in Work with Youth» (39.04.03), and Further education programme «Juridical Psychologist delivered by the Federal State Autonomous Educational Institution of Higher Professional Education "North-Caucasian Federal University" for the period of 6 years.
