

ACHIEVEMENTS OF THE STUDY PROGRAMMES

Quality of implementing the study programmes

The analysis of quality of students' training is carried out on the basis of evaluation of admission requirements, learning outcomes on all disciplines of the curriculum, interim and final state attestation of graduates.

The University ranks 1st in the ranking of pedagogical HEIs on quality and the number of state-financed openings.

22 graduates have a title «Uchitel Goda» (Teacher of the Year).

Provision of up-to-date education

The up-to-date content of education is ensured by annual renewal and adjustment of the educational programmes, curricula and programmes of disciplines in accordance with the changes in the federal and regional legislation, their agreement with employers and stakeholders, with the account of international practice. The programme of retraining is annually updated with the account of employers' opinions and remarks and suggestions of the students in the feedback questionnaires.

Teaching staff

The teaching staff comprises highly-qualified teachers having academic titles and degrees (the academic degree holders rate is 90%). 70 teachers deliver the cluster of the educational programmes, 18,6% of them are Doctors of Sciences, 71,4% of them are Candidates of Sciences.

The competence of the teaching staff is highly evaluated on the regional and national levels.

Independent assessment of student learning outcomes

A high level of students training is approved by their participation in international, national, regional and interuniversity olympiads, conferences, and competitions where they become winners and holders of awards.

The representatives of public organizations participate in independent evaluation of graduates' training.

The University participates in the projects of the Federal Internet Exam in Higher Education and the Federal Internet Exam for Bachelors.

Educational resources

There are 19 classrooms for delivering lectures and holding seminars provided with the tools for visualization and transmission of graphical information, computers with an access to databases, local network of the University and the Internet.

Since 2012 the library provides an access to electronic library systems «University Library Online», «Lan», «Urait».

On September 1, 2019 the library stock comprised 1 599 132 printed publications and 152 665 electronic publications.

The reference rooms provide an access to full-text electronic archives of leading foreign research journals: Cambridge University Press, Oxford University Press, The Institute of Physics, Royal Society of Chemistry, Nature, Science, etc.

Research activity

The teachers actively participate in research activities of the region, conferences, seminars and internships in other Russian regions and abroad, publish the results of their research in leading journals of Russia and foreign countries, including international citation bases of Scopus and Web of Science.

Many research developments are used in the educational process, in the programmes of the main disciplines, original coursebooks and study guides.

Academic mobility of students

The University actively develops international partner ties, provides the possibility for foreign students to study at the University and allow the students to serve internships at the universities of Germany, Poland, Belgium, Spain, Italy, North Korea, China, and Romania.

The students showing high academic achievements are financially supported in the form of increased scholarship.

Employability of graduates

For the last 5 years graduates' employability rate remains high and is 95% on the average. The information on graduates' employability is published on the portal of the Department of Career Guidance and Employability Support of the University.

International projects

Currently the University signed 102 cooperation agreements with different universities from Germany, Poland, Belgium, Spain, Italy, North Korea, China, Romania, etc. In terms of agreements mobility of students, teachers and researchers is developed, research conferences and seminars are held, the educational process at certain faculties is optimized, joint research works and developments are carried out.

COMPLIANCE OF THE EXTERNAL REVIEW OUTCOMES WITH THE STANDARDS

STANDARD 1. Policy (goals, development strategy) and quality assurance procedures of a study programme

Compliance with the standard: full compliance

Good practice:

The University mission reflects the principles of maintaining the best practices of the Russian pedagogical school and account of modern tendencies and innovations in pedagogy.

The strategic goals and ways of their achievement are set.

The goals and strategic objectives of the Faculty of Pedagogy and Psychology comply with the Development Concept of the University and are taken into account by the administration and teachers.

Areas for improvement:

All stakeholders including partner organizations, employers and students should be involved in design of the development strategy of the Faculty.

STANDARD 2. Design and approval of programmes

Compliance with the standard: **full compliance**

Good practice:

The educational programmes have clearly defined goals that correspond to the University mission, strategic goals and objectives of the educational institution and demands of applicants.

The procedures of development, approval and adjustment of the educational programmes are clearly defined.

The educational programmes are developed on the basis of the Federal State Educational Standards and professional standards, including expected learning outcomes defined with the account of the development of science and industry and opinions of stakeholders (administration, teachers, students, employers).

Annual increase in the number of applicants is indicative of high demand for the programmes of the cluster under accreditation.

Areas for improvement:

The expected learning outcomes for Bachelors and Masters should be defined in a single document; the applicants should have a free access to this document.

The representatives of professional community should be involved in the educational process to carry out practical training with the students.

STANDARD 3. Student-centred learning and assessment

Compliance with the standard: full compliance

Good practice:

The teachers and the administration take into account student opinions: a unique system of students' incentives is created to encourage them to participate in social, creative and volunteer activities by means of optional credits to the main educational course.

Interactive methods promoting students to actively participate in the joint design of the educational process are used.

The students together with the teachers do research in terms of graduation theses on the basis of the applied educational institutions, the results of which can be used in different educational practices.

Areas for improvement:

Additional language training for the students should be organized.

The students should be informed about the possibility of making an individual learning path (for example, selecting the subjects).

STANDARD 4. Student admission, support of academic achievements and graduation

Compliance with the standard: **full compliance**

Good practice:

Career guidance is effectively organized: School of a Young Teacher-Psychologist, University Saturdays, Open Doors Days, etc.

Academic performance is monitored during the whole term with the help of the point rating system. Various additional scholarships promote students to enhance their academic and social activities.

The system of taking into account extracurricular activities of the students is created.

Areas for improvement:

The Diploma Supplement should be given to all students (graduates).

The strategic programme of education internationalization should be developed; it should represent the ways promoting student mobility and export of educational services (involvement of foreign students).

STANDARD 5. Teaching staff

Compliance with the standard: **full compliance**

Good practice:

The academic degree holders' rate is high. The teaching staff comprises well-known professors having great experience of practical work, including world known researchers.

An effective system of financial and non-financial incentives for the teachers taking into account all kinds of work (educational, research, international) is in place. The performance-based contract of employment is used.

The innovative methods of teaching and advanced technologies are used in the educational process.

The teachers actively carry out research, the results of which are presented at conferences, seminars, in publications in leading Russian and foreign journals and in the international citation bases of Scopus and Web of Science.

Areas for improvement:

The programme of international activities should provide for additional funding for the programmes of academic mobility of teachers, their participation in joint international projects and internships abroad.

A clear system of qualification and professional development of teachers in relation to their language proficiency and digital competence should be created.

Teachers from other educational institutions including the foreign ones should be involved to deliver lectures.

STANDARD 6. Learning resources and student support

Compliance with the standard: **full compliance**

Good practice:

Good conditions for extra-curricular activities of the students are created.

The educational programmes are provided with laboratory equipment and computer hardware.

The Faculty of Pedagogy and Psychology is located in the individual comfortable building.

Feedback from the students on evaluation of conditions and organization of the educational process is carried out through cooperation with the Student Council of the University, Faculty, Institute of Childhood, leaders of student groups by means of questionnaires, meetings, social media, etc. The students use the resources of the Montessori Centre, historic classrooms, museum complex as a unique component of material and technical resources.

Areas for improvement:

The ways of informing students about the possibilities of academic mobility and the systems of its support should be extended.

The educational services for students with disabilities should be made more available.

STANDARD 7. Collection, analysis and use of information for managing the study programme

Compliance with the standard: **full compliance**

Good practice:

The system of collection and information on the results of the University activities is used.

The University used the system of electronic document flow Directum, corporate e-mail, corporate information system of the educational institution «Galaktika».

The electronic informational and educational environment is effectively used at the University.

Areas for improvement:

Stakeholders (teachers, parents, employers, students, graduates) should be more involved in the analysis of the collected information about the educational programmes.

STANDARD 8. Public information

Compliance with the standard: **full compliance**

Good practice:

The University has special services that are responsible for public information and maintaining relations with the federal and regional mass media and employers.

The University publishes up-to-date and reliable information on its official website that effectively works.

The information on graduates' employability is provided by the Department of Career Guidance and Employability Support of the University.

Areas for improvement:

The English version of the website regarding the cluster of the educational programmes in «Psychology and Pedagogy» (44.03.02, 44.04.02) should be extended in order to involve foreign students.

STANDARD 9. On-going monitoring and periodic review of programmes

Compliance with the standard: **full compliance**

Good practice:

The monitoring and regular review of the educational programmes on the University level are carried out on the basis of internal and external evaluations. The main monitoring procedures are the following: compliance of the University documents with the requirements of the federal regulatory and methodological documents in the sphere of education; survey of the teaching staff and students; students' participation in independent evaluation of education quality; internal audits of the educational process.

Areas for improvement:

The feedback mechanism (survey, interview of students, graduates, employers) should be more widely used to ensure correspondence of the programmes to the demands of the developing society.

STANDARD 10. Cyclical external quality assurance of study programmes

Compliance with the standard: **full compliance**

Good practice:

The Faculty regularly participates in external national and international procedures of quality evaluation of the educational programmes; it provides the public with objective information on the quality of the University performance.

An effective system of corrective actions on the results of external reviews is created at the University and includes the analysis of the structure and content of the tasks that help to carry out quality evaluation of the educational programmes.

Areas for improvement:

The practice of carrying out regular external review of the quality of educational programmes should be maintained as it contributes to the development of the Faculty and pursuing educational, research and other possibilities for students and teachers.
