#### **EQEA** (China):

National Research Tomsk State University

Questions were asked.

V. Bolotov: What were the most interesting things about the external review?

A. Yamashkin: Great material and technical resources, in-depth research, highly qualified teaching staff. Dean of the TSU Faculty of Geology and Geography spoke at the meeting of the Federal Academic Methodological Association about growth prospects. The students made a great impression. Experience of work and communication with Chinese colleagues is interesting. TSU is a modern university aimed at the development of the Russian East. Recommendations of the panel were aimed at the university and faculty development. All points of growth are highlighted by TSU itself.

Questions were asked.

- V. Bolotov: Why did the external review panel gave the summative assessment «substantial compliance»? What was lacking for «full compliance»?
- A. Mikliaeva: Good material and technical resources do not guarantee the fundamental character of education; the training is too practice-oriented. The overall goals of study programmes are not defined.

### Bilim-Standard (Kyrgyzstan)

## Kyrgyz National University named after J.Balasagyn

Questions were asked.

- V. Bolotov: Why the marks for the IT cluster are lower than for the other clusters?
- A. Schukin: The level of the study programmes is high; the university closely cooperates with the professional community. The external review panel outlined the growth path of the study programmes, in particular, the development of a new study programme that could cover a wider scope of knowledge and competences. To take into consideration instructional techniques that are more suitable for the IT study programmes. To enhance cooperation with partner foreign IT companies.
- V. Filippov: To what extent the programmes of the cluster «Oriental Studies» comply with the international requirements for learning the oriental studies and sinology?
- E. Khabibullina: The Russian school of oriental studies laid the foundation for the study programme under review; the university closely cooperates with Chinese HEIs

that allows the university to be on a world level. The programme is too practiceoriented, that is why it is recommended to enhance research component of Master students training.

E. Esentaev: We plan to continue cooperation with NCPA; the university is preparing for the new stage of joint accreditation. NCPA greatly supports the Kyrgyz agency in organization and methodology.

#### IAAR (Kazakhstan)

 Ural State Medical University of the Ministry of Healthcare of the Russian Federation (against WFME standards)

Questions were asked.

- V. Bolotov: Is there a fundamental difference in standards and approaches to accreditation of two agencies?
- E. Kiseleva: WFME has a student-centered approach; the accreditation process is built on stakeholders' opinion.
- A. Chaplygin: How the Ministry of Health of the Russian Federation and the Association of Medical Universities are related to this accreditation?
- V. Bolotov: The Ministry of Health can not and should not support this approach due to political reasons.
- V. Filippov: There are many agencies in the world that carry out accreditation of medical programmes. The university chooses the agency itself.
- G. Motova: Russian medical HEIs are interested in international recognition of their study programmes as it attracts foreign applicants for whom international quality recognition of study programmes is important. Russia does not have quality assurance agencies recognized by the World Federation for Medical Education, that is why Russian HEIs do not have much choice: either to be accredited by **IAAR**, or to undergo a joint accreditation by NCPA that is recognised in Russia and abroad.
- N. Zhernakova: The recommendations were aimed at greater public awareness of the mission and goals of the HEI and the study programmes. The external review was specifically focused on student-centered learning. I would like to mention high quality clinical facilities partners of the university.

- V. Filippov: I suggest we should trust opinions of our colleagues.
- V. Bolotov: I invite experts to share their experience about a joint external review and publish an article in one of the reputable journals.
- G. Motova: I suggest preparing a report about the joint accreditation of medical programmes and sending it to the Ministry of Healthcare.

Questions were asked.

V. Bolotov: Dear experts, please share your thoughts.

- V. Sushinskiy: I think that the study programmes should be accredited as the university showed good results. Russian and Belarusian HEIs have much in common.
- S. Poroyskiy: Accreditation does not give employment privileges. It enables to train foreign students in medical study programmes. The goal of accreditation is not to search for drawbacks, but to give recommendations for improvement.

## Bashkir State Agrarian University

Questions were asked.

- V. Bolotov: What was the inclusion of the study programme «Construction» (08.03.01, 08.04.01) in the cluster «Environmental Management» driven by? The same question is about the study programmes «Power Industry» and «Transport»?
- A. Aldungarova: In this case the profile of the studied disciplines is oriented to agricultural construction and design of the agroindustrial complex.
- A. Stepovoy: The common features of these study programmes are programmes in agricultural engineering and engineering components.

Zh. Beksultanov: I liked that the University' staff has positive attitude and the academic degree holders rate is high. I would like to mention the relations between the educational institution and the professional community.

## Russian Timiryazev State Agrarian University

Questions were asked.

V. Bolotov: Dear experts, please share your thoughts.

A. Aldungarova: The HEI and experts worked as a team. The level of the study programmes is very high.

A. Scherbak: The infrastructure and equipment are on a high level; the students are greatly satisfied with the educational process. The university provides conditions for self-development and realization of students' potential. The growth point for the programmes of secondary vocational education is enhancing the electronic educational environment.

#### Institute of International Economic Relations

Questions were asked.

V. Bolotov: We would like to hear the feedback about accreditation of a non-state HEI.

A. Nasyrov: The University has strong traditions, the graduates are aware of their career path. An individual learning path is in place. The programme «Digital Economics» is delivered; it favorably distinguishes the university. The study programme's profile is foreign economic activities. The panel strictly evaluated the programmes, gave clear recommendations for improvement: to enhance research, to provide financing for the software, to pay attention to qualification enhancement of the teaching staff in mastering foreign languages, to expand its geographic reach. Panel's recommendations do not drastically influence the state of the study programmes.

A. Chaplygin: It is the university under the Russian Foreign Trade Academy, we know it, it exists for almost 30 years.

## Moscow State University of Civil Engineering (pilot LTA-technology)

Questions were asked.

- V. Bolotov: Dear colleagues, members of the Board, what do you think about LTA accreditation?
- E. Zima: This procedure makes HEIs' life easier as it solves many issues while preparing for accreditation. At the same time, it deprives the university's staff of the opportunity to communicate with the experts directly.
- V. Ponka: We should not be afraid of new steps; life is changing; we should be changing too.
- V. Bolotov: So, colleagues, we come to a conclusion that you support the idea of LTA-accreditation. It should be focused on the growth points of the study programmes.
- L. Zhuravleva: One of the recommendations for the university was to inform the public about their unique character and to be more open.
